SCHOOL TAXES — School budgets are prepared and adopted locally in the respective school districts and the amount shown on the accompanying bill is collected solely for the benefit of your school district. The Receiver of Taxes acts merely as an agent for the collection of such taxes. For further information concerning school budgets, consult your local school authorities.

IMPORTANT NOTICE — Taxes become a lien on December 1, 2005. First half payable to Receiver of Taxes at 100 Main Street, Huntington, N.Y. 11743 on or before January 10, 2006 without penalty. Second half payable on or before May 31, 2006 without penalty. Thereafter all taxes are payable to County Treasurer at Riverhead, 330 Center Drive, Riverhead, NY 11901-3311 plus penalty and interest.

EXPLANATION OF CODES — EXAMPLE: Code No. 135 equals the sum of 5+6+7+8+9+14+20+21+22+40.

To compute the tax for any individual district, multiply the assessed valuation shown on tax bill by the tax rate shown for that district. The total tax rate equals the school district rate, plus the library district rate, plus the combined code rate. **N.Y.S. Veterans Exemption shown on your tax bill applies to Codes 1-4, 5, 6, 7, 8, 9, 21 and 22.**
