INVENTORY

General Business Law §583 requires that the application to conduct a "closing out sale" or a "sale of goods damaged by fire, smoke or water" or a "defunct business sale" shall include a full, complete, detailed and itemized inventory of the goods, wares and merchandise to be offered at such sale as disclosed by the applicant's records, which inventory shall:

(i) Itemize the goods, wares and merchandise to be offered for sale with sufficient information concerning each item, including quantity, make brand name, model and manufacturer's number(s), if any, to clearly identify it.

(ii) Separately list those goods, wares and merchandise to be offered for sale which were purchased and received during a 90 day period immediately prior to date of application.

(iii) List the total retail value of the inventory of goods, wares and merchandise to be offered for sale based on the inventory used for applicant's most federal income tax return adjusted for sales and purchases.
