There were no bias-related incidents in the Town of Huntington during the month of May. However, at the end of the month we saw the first of several protests related to the appalling death of George Floyd. As our police commissioner has stated, we are horrified by this unnecessary and tragic death. Officers in this precinct, in the county, and around the country are outraged by the video. As I write this, there have been no incidents of damaged property or injured people at any of the protests in our precinct. The credit for this goes to many people. It is a result of the pragmatism of the protest organizers, the temperance of the protesters, the guidance of the community leaders, and the professionalism of the members of our department. I thank everyone involved who participated in these events and contributed to crime-free events across the town.

The residents of Huntington should be aware that the SCPD is taking proactive steps to ensure the safety of residents and protestors as demonstrations continue. Residents should also be aware that the department has worked for years to maintain and improve relations with members of all communities. Over the past several years, the department has implemented and improved relevant policies, including bias-free policing training, training in de-escalation techniques, scenario-based training in use of force, and officer accountability. ### HABTF Hosts Community Conversation on Biased Real Estate Practices



On December 19th, with just three weeks' planning time, the Huntington Anti-Bias Task Force (HABTF), hosted a community conversation on how Huntington can respond to the November Newsday series which exposed racial steering and other forms of illegal housing discrimination in Long Island's real-estate industry. We were delighted that, of the 30 people who attended, about 12 were real-estate agents, including a representative of the LI Board of Realtors. Others in attendance were supporters of HABTF including local clergy and community activists.

Ian Wilder, Executive Director of LI Housing Services, a

nonprofit agency that since 1969 has tested for racial discrimination in Long Island's housing market, did an excellent job moderating. He was non-threatening while being direct about the abuses uncovered by Newsday.
