

Divisions

- ☐ Security: Daily patrols of 77 town buildings, beaches and parks and railroad stations. Parking enforcement throughout the Town, both on-street and LIRR stations.
- Park Rangers: NYS certified armed peace officers assisting security officers.
- □ <u>Code Enforcement</u>: Investigate citizen complaints, ensure compliance with state and local property codes, signage and accessory apartment enforcement.
- Animal Control: Operate town Animal Shelter and ensure compliance with state and local animal care laws.
- ☐ <u>Special Services</u>: Parking space and meter maintenance and repair. Abandoned vehicle identification and removal.



Mission

- □ Public Safety strives to enhance the quality of life in the Town of Huntington by providing a safe and secure environment through the enforcement of Town codes and municipal regulations.
- □ Public Safety operates a 24-hour, 7 day a week communication center which serves as a vital link providing real time information to the Public Safety Agents and Park Rangers, as well as to the public.



2020 Achievements

- □ Public Safety maintained operations at 100% workforce throughout COVID 19 pandemic to insure the safety of Huntington residents.
- □ Park Rangers personnel increased by 50% along with an increase in operational capabilities to secure public events.
- ☐ Animal Control division continued to set a standard of excellence in rehabilitating dogs.
- ☐ Code Enforcement worked closely with Information Technology Division to prepare for the successful launch of the Bureau of Administrative Adjudication



2021 Goals

- □ Continue to research and deploy latest technologies and processes to streamline operations and improve efficiency within the five divisions of Public Safety.
- ☐ Further expand the Park Rangers division to enhance the ability to protect the public at Town beaches, parks, buildings and facilities. Enhance focus on officer safety and equipment standardization.
- Expand community outreach and improve connection to the public to be better able to respond to resident complaints.
